



## **ANNUAL GENERAL WAIVER AND PHOTO RELEASE FORM FOR NAVARRO FARM**

### **IMPORTANT INFORMATION**

The Navarro Farm is committed to conducting its recreation/farming program services in a safe manner and holds the safety of participants in high regard. The Navarro Farm continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participant's safety. However, participants and parents/guardians of minor children/wards registering for programs/ volunteering and all activities must recognize that there is an inherent risk of injury when choosing to participate in recreational and farming activities / programs. You are solely responsible for determining if you or your minor child/ward is physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable especially if the participant is disabled in any way recently suffered illness injury or impairment, or is pregnant, to consult a physician before undertaking any physical activity.

### **WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTIONS OF RISK**

Please read this form carefully and be aware that in signing up and participating in programs/activities/volunteering, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with said programs/activities.

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities and I voluntarily agree to assume the full risk of any and all injuries damages or loss, regardless of severity and that my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in any and all activities, connected with and associated with these programs/activities.

I do hereby agree to fully waive, relinquish release and forever discharge the Navarro Farm including its officials, agents, volunteers and employees hereinafter collectively referred as Navarro Farm from any and all claims for injuries damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of connected with or in any way associated with these programs/activities.

I further agree to indemnify and hold harmless and defend Navarro Farm from and against any losses, claims damages to property occurring, growing out of incident to or resulting directly or indirectly from my minor child/ward or my participation in any and all activities connected with and associated with these programs/activities.
